Dear Mr Dickens,

As you know the examination of the New East Devon Local Plan 2006-26 began on submission on 2 August.

The submission documents include a Proposed Submission (Publication) version of the Plan¹ and a schedule of proposed minor publication changes to the Plan approved by the Council on 18 July 2013². I presume it is the latter version you wish me to consider but I would welcome your confirmation of this.

I note that the Council considers the proposed changes to be minor and not significant enough to justify additional consultation. Attached as Appendix 1 is a list of changes I do not consider can be described as minor as they either, in my view, introduce significant new material or result in significant changes to the way policy would be applied. I do not consider that the extent of consultation on the proposed changes (as set out in the committee minutes included in CD/SD002) complies with the Council's Statement of Community Involvement³ or regulation 18 of the Town and Country (Local Planning)(England) Regulations 2012.

Consequently, I do not consider that it would be in the interests of natural justice for me to consider the proposed changes unless they are subject to consultation in accordance with the Council's Statement of Community Involvement and the Regulations. It is a matter for you but it may be prudent to consult on the all the changes set out in CD/SD002.

I look forward to hearing from you with regard to the above and, should you wish me to base my examination on the Plan as amended in CD/SD002, a timetable for consultation.
