Obtaining your personal information

Information will have been provided to us by you as the individual complainant.

The information we process includes your name and contact details and possibly medical information relevant to your complaint.

Use of your personal information

We are using your personal information for the purpose of investigating the complaint and on the basis of public task and our legal obligation to deal with statutory nuisance under the Environmental Protection Act 1990 and Anti-Social behaviour legislation.

Where we process special category data such as medical information, relevant to the complaint, we will only do so with your consent.

Who will receive or see my personal information?

Your personal information will be available to be seen by those within the Environmental Health Team for the purpose of investigating your complaint and within support services (such as the Legal, HR, Insurance and wider Finance Teams and third party payment handler) where necessary to carry out the purpose.

We may share information with our Planning team and with external organisations such as Devon County Highways Authority in the process of investigating and dealing with your complaint but your personal data will only be shared with your consent.

We may also share information with our corporate safety officer when our staff safety is viewed as being at risk. Information may also be shared with partner agencies during safeguarding investigations and for fraud identification and prevention.

Your personal information will be stored securely and will not be accessible to anyone else, including other services within the Council, unless detailed above

Retention

All your personal information will be held by us only for as long as is necessary and then in accordance with any legal requirements imposed upon us and the Council's retention schedule. For more information please go to our website to view our [Retention schedule](#)

Transferring personal information outside of the EU

Your personal information will not be transferred outside the EU or to any international organisations by the Council. It should be noted that the Council has no control over those accessing its online public registers nor what someone does with any information they obtain from them.

Your rights

Whatever our use of your personal information you have the right of access to that personal information (this means confirmation that we are using your personal information, access to it as well as other detail) and the right to seek rectification if the information is inaccurate.

Where we are processing your personal data on the basis of public task and legal obligation you may have the right to object and the right to restrict processing.

Where we are processing your personal data on the basis of your consent, you have the right to withdraw consent.

Also, if you object to our use of your personal information and there is no overriding legitimate interest for us to continue using it or we have used your personal information unlawfully or it is no longer necessary for us to have the personal information, the right to erasure is also available to you.

Complaints
